This product can be mixed with most fertilizers and chemicals. Use as part of a complete turf fertility program. A compatibility test should be performed prior to use. Shake product prior to use. Maintain agitation during mixing and application.

Golf Course Greens	Apply 1.0 to 6.0 fl oz per 1000 sq ft in 0.5 to 2.0 gal spray solution per 1000 sq ft. Repeat application every 7 to 14 days during the growing season. Transition and warm season turf may require higher rates.	
Golf Course Tees and Fairways Sports Turf	Apply 1.5 to 6.0 fl oz per 1000 sq ft in 0.5 to 2.0 gal spray solution per 1000 sq ft. Repeat application every 2 to 3 weeks during the growing season.	
Residential and Commercial Lawns	Apply 1.0 to 2.0 gal per acre in 25 to 88 gal per acre of spray solution. Repeat application every 6 to 8 weeks.
